TERMS AND CONDITIONS

In consideration of the applicant's use of the above Cordry Sweetwater Conservancy District (CSCD) facilities, the parties hereby agree as follows:

1. Cancellation procedure: If this facility use permit must be cancelled, the applicant must contact the Conservancy Office prior to the event date.
2. Damages: Applicant shall be liable and responsible for any and all damages or destruction incurred to the facility and equipment during the period of this agreement. The applicant further agrees to pay CSCD the actual costs to repair or replace the damaged or destroyed property. CSCD shall have no liability to the applicant for any damages to its property located in or about the premises regardless of the cause.
3. Applicant's responsibility
 - Responsible for the behavior and actions of any individual using CSCD facility during this permit.
 - This agreement is not transferable, nor shall the applicant, under any circumstances, sublease this use without the prior consent of the CSCD.
 - Responsible for overseeing parking of vehicles in designated areas only.
 - Responsible for any damages to the CSCD facilities and its grounds during the use period.
 - Responsible for the proper installation and removal of any deliveries, decorations and equipment.
 - Following the use period, applicant must return the facility to a condition similar to or better than before the use period.
 - All trash and debris must be disposed of properly.
 - Sound amplification of any type must be approved prior to event date by the CSCD
 - This use agreement covers facility and grounds only.
4. Applicant's waiver of liability: The applicant and any other person, corporation or other organization on whose behalf a permit is granted, agrees to indemnify and hold harmless the CSCD, its members, officers, agents, employees and contractors from any and all liability, claims, demands, right of actions, loss, cost, damages or expenses (including attorney fees) on account of the revocation of this permit, or for any injury to, or death of, any person(s) or instance of damage to applicant's property, when injury, death or damage arises out of or is any way connected with the presence of the applicant, applicant's invitees, agents and employees on the premises of the CSCD.

I have read and understand the policies that pertain to the use of a facility of the CSCD and agree to their contents. I further agree to comply with all stated regulations of the CSCD and hold harmless the CSCD and its agents, representatives and employees from any and all liability resulting from applicant's use of the facility/grounds.
