### CSCD Advocacy Committee Mission

This committee will act in an advisory capacity to the CSCD Board. It will develop and present ways to better engage outside entities/organizations/government offices on behalf of the CSCD. The Committee will consist of five Freeholders (with an option for the CSCD Board to increase it to seven members) and a maximum of two current CSCD Board members, one of which will be the Chairperson for the Committee.

The Freeholders on the Committee will formulate a series of options, to be presented to the CSCD Board, that will identify and help develop processes towards a strategic goal. The strategic goal: 1) to increase and improve the communication and relationships between the District and Brown County Government and Offices, plus other organizations when identified, 2) to have Brown County Tax Revenues generated from the Conservancy and its taxpayers be invested in the Conservancy District as applicable, 3) to pursue possible zoning changes.

The Committee CSCD Board Member (or both members), will serve as a guide, moderator, go-between, and scheduler to the Freeholder Members.

A seat on the Advocacy Committee will consist of a majority number of members (three) who will serve a two-year term, and for 2021, a minority number (two) with a one-year term. After one year of CSCD Advocacy Committee existence (i.e., beginning in 2022), all Member Terms will be two years. Each member will be annually renewable by the CSCD Board. As the Advocacy Committee will be a central part of the information needed for strategic planning and relationship building, each person volunteering should understand that attendance at Advocacy Committee Meetings is important. Meetings could occur twice a month. Attendance at meetings of identified entities/organizations (i.e., located outside of the Conservancy) will most likely be required. A lack of meeting attendance may lead to a person being removed from the Committee by the CSCD Board.
